## **Responsible Entity**

Ironbark Asset Management (Fund Services) Limited ABN 63 116 232 154 AFSL No. 298626 is the responsible entity of the Fund and issuer of this PDS ('Responsible Entity', 'we', 'us', 'our'), a wholly owned subsidiary of Ironbark Asset Management Pty Ltd ABN 53 136 679 420 AFSL No. 341020, collectively referred to as 'Ironbark', as the context requires.

Ironbark is an Australian incorporated company licensed to be a responsible entity, and holds an Australian financial services licence to operate registered managed investment schemes.

The Responsible Entity is bound by the Constitution and the Corporations Act. The Responsible Entity has lodged a compliance plan with ASIC which sets out the key measures which the Responsible Entity will apply to comply with the Constitution and the Corporations Act. The Responsible Entity has established a compliance committee with a majority of external members ('Compliance Committee'). The compliance plan is overseen by the Compliance Committee and is audited annually with the audit report being lodged with ASIC.

Ironbark and its related entities are a diversified financial services business providing solutions across asset management, responsible entity, trustee and wealth.

Through our strategic partnerships with international and Australian investment managers, Ironbark provides investment solutions across a diverse range of asset classes including Australian and international securities, alternative investments, domestic and global property securities, and fixed interest securities.

As at 30 June 2023, Ironbark and its related entities have over \$60.8 billion funds under management, trusteeship and advice.

# **Investment Manager**

Ironbark has appointed Infinity as the investment manager of the Class.

Infinity is an Australian Financial Services Authorised Representative ('AFSR') (AFSR No. 001254429) of Infinity

Capital Solutions Pty Ltd ABN 41 621 447 345 AFSL No. 515762 ('Infinity Capital Solutions') and is authorised to provide certain financial services on its behalf.

Infinity is the investment management business of the Viridian Financial Group, a diversified financial services company. As of 30 April 2023 Infinity has \$3.2 billion in assets under management across a range of underlying asset classes. Infinity has an experienced investment team with over 100 years of combined industry expertise with several of the team having worked together at multiple organisations. Infinity adopts an active approach to managing investment portfolios with an integrated focus on sustainable investing. Infinity's investment philosophy is built on the premise that financial markets are inefficient over the short to medium term and that appropriate asset allocation along with security selection can be utilised to effectively reduce overall investment risk while providing the opportunity to add value through a market cycle.

Ironbark through its related entity holds an investment interest in Viridian Financial Group Ltd ABN 67 605 994 741, a related party to Infinity.

#### Consent

Infinity has given, and not withdrawn, its written consent to be named in this PDS in the form and context in which it is named and for the inclusion of information about it in this PDS and the AIG. Infinity has not authorised or caused the issue of, and takes no responsibility for, this PDS or the AIG, other than the inclusion of the information about Infinity.

### Other service providers

The Responsible Entity has appointed State Street Australia Ltd ABN 21 002 965 200 AFSL No. 241419 as the custodian, administrator and provider of unit registry services to the Fund ('Custodian' or 'Administrator' or 'Unit Registry'). The Custodian has no supervisory role in relation to the operation of the Fund and is not responsible for protecting your interests.



# How the Infinity Asset Management Fund works

The Fund is structured as a unit trust that is a managed investment scheme under the Corporations Act and is registered with ASIC. When you invest in a class of the Fund you will be allocated a certain number of units and your money will be pooled together with other people's money. This pool of money will be used to acquire investments, in accordance with the Class's investment strategy, that will be managed by the Investment Manager on behalf of all investors. Investors do not have day to day control over the operation of the Class of the Fund.

Investors receive units in the Class when they invest in the Class. Each unit gives investors an equal, beneficial interest in the Class. However, it does not give the investor an interest in any particular asset of the Class or the Fund.

The Constitution allows the Responsible Entity to issue different classes of units. Different classes of units generally represent different levels of rights and interests.

### **Units in the Class**

Generally, unit prices are calculated each Business Day. The unit price is calculated by taking the total market value of the assets of the Class less the total value of the liabilities of the Class ('net asset value' or 'Class NAV'), adjusted for the buy/sell spread divided by the total number of units on issue at the relevant valuation time.

When you invest, we issue you a number of units depending on the amount you invest. Similarly, when you withdraw from the Class, we calculate your withdrawal proceeds by reference to the number and value of units you hold at the time of withdrawal.

The Responsible Entity determines the unit prices of the Class based on the most recent valuation of assets, property and liabilities (which are determined at regular intervals appropriate to the nature of such assets, property and liabilities). Generally, the unit price of the Class will change as the market value of assets in the Class rise or fall.

Unit prices will be available at www.infinityassetmanagement.com.au. You can obtain a copy of the Responsible Entity's Unit Pricing Discretions Policy and records of any exercise of such discretions under the Unit Pricing Discretions Policy, free of charge by contacting the Responsible Entity.

# Applying for units

# **Direct investors**

You can acquire units by completing an Application Form. The minimum investment amount for the Class is \$25,000.

You can make additional investments into the Class at any time by completing an application form, which is available at www.infinityassetmanagement.com.au or by submitting a written request in the format advised by Unit Registry. The minimum additional investment into the Class is \$5,000.

# **Processing applications**

Units are generally issued after the completed Application Form and application money has been received and accepted by Unit Registry on behalf of the Responsible Entity. If your application is received by 2.00pm on a Business Day and it is accepted, your units will generally be issued based on the unit price for that Business Day. If your application is received on or after 2.00pm on a Business Day and it is accepted, it will be considered as being received on the next Business Day. All times quoted in this PDS are Sydney time (unless otherwise specified).

The Responsible Entity can accept or reject any application for units in its discretion and is not required to give any reason or grounds for such a refusal.

## **Indirect Investors**

The Responsible Entity authorises the use of this PDS for investors who wish to access the Fund indirectly through an investor directed portfolio service, a master trust, wrap account or, investor directed portfolio scheme or similar arrangement ('IDPS') by directing the IDPS operator to acquire units on your behalf. If you do so, you will need to complete the relevant forms provided by the IDPS operator. The IDPS operator's withdrawal conditions determine when you can withdraw. The Responsible Entity is not responsible for the operation of any IDPS. Your rights as an Indirect Investor should be set out in the disclosure document issued by the IDPS operator and you should read the disclosure document for that IDPS together with this PDS prior to investing.

# Access to your money

Investors of a Class in the Fund may request to withdraw some or all of their investment by either completing a withdrawal form available at www.infinityassetmanagement.com.au or providing a written request in the format advised by Unit Registry.

## **Processing withdrawals**

If your valid withdrawal request is received by 2.00pm on a Business Day, your units will be redeemed based on the unit price for that Business Day. If your withdrawal request is received after 2.00pm on a Business Day, it will be considered as being received on the next Business Day. All times quoted in this PDS are Sydney time (unless otherwise specified).

A minimum withdrawal amount of \$2,000 applies.

The minimum account balance for the Class is \$5,000. The Responsible Entity reserves the right to waive this requirement and allow for balances below \$5,000. Should the withdrawal bring your account balance below \$5,000, the Responsible Entity reserves the right to assume and facilitate a full withdrawal of your account. While the Class is liquid, withdrawals will usually be paid to your nominated bank account within 10 Business Days. However, the Constitution allows the Responsible Entity up to 21 days of the date on which units ar taken to be redeemed to pay withdrawal requests that it has accepted, to pay withdrawal requests after the next valuation time following the receipt of the withdrawal request.

If the Fund is suspended, restricted or there is a freeze on withdrawals, Unit Registry will not process withdrawal requests within the usual period. Any decisions whether to process withdrawals or partial withdrawals will be made in the best interests of investors as a whole and in accordance with the Constitution.

During a distribution period and financial year end, there may be delays in processing your application and withdrawal requests and you may not be able to withdraw your investment within the usual timeframe.

## Transferring units

You may transfer units in the Class to another person, with the consent of the Responsible Entity.

#### **Distributions**

Any income distributions are generally paid semi-annually. Distributions are determined on a class by class basis. The distributions are calculated based on the Class's distributable income at the end of each distribution period ending 31 December and 30 June, and paid to investors in proportion to their unitholding. Subject to the law, Ironbark may change the distribution frequency without notice.

Investors can elect to have their distribution reinvested or paid to a nominated Australian bank account. Investors who do not indicate a preference will have their distributions automatically reinvested. Investors will still be subject to tax on any distribution even if they elect to reinvest. There is no buy/sell spread with reinvestment of distributions.

Concentration risk	The Class has a concentrated portfolio, meaning it holds a limited number of investments and/or takes large positions in a relatively small number of securities. If one or more of these investments declines or is otherwise affected, it may have a pronounced and potentially adverse effect on the Class's value.
Small capitalisation investment risk	Small capitalisation companies in which the Infinity SMID Australian Equity Class is permitted to invest, generally have a lower degree of liquidity (i.e. they are generally more difficult to trade) and a higher degree of volatility than larger capitalisation securities. Also, publicly available information on their business activities may not be easy to obtain compared to larger capitalisation securities.

# Fees and costs

#### **DID YOU KNOW?**

Small differences in both investment performance and fees and costs can have a substantial impact on your long term returns.

For example, total annual fees and costs of 2% of your account balance rather than 1% could reduce your final return by up to 20% over a 30 year period (for example, reduce it from \$100,000 to \$80,000).
